REFUND POLICY

- A) Where an Enrolment is subsequently Withdrawn, Refunds may be applied to the following circumstances & conditions:
- Where written notice of withdrawal is received **prior to & up to 1 December 2019** a Refund will be awarded subject to a 30% cancellation fee.
 - Where written notice of withdrawal is received **after 1 December 2019** a Refund will not be awarded and a cancellation fee of 100% will be applied.
 - Once summer camp has started and a student suffers from Total incapacitation due to medical reasons, a refund (less \$100 Cancellation Fee) will be awarded only where a detailed medical certificate is provided. The medical certificate must state that the student is suffering from Total incapacitation at the time of the program.
 - Should any of the programs be cancelled due to insufficient numbers, students shall be entitled to a full refund.
 - Advanced notice in writing is required for any applications for refunds (except item A3). No refunds will be considered after the completion date of each program.
- B) Fees are non-transferable to another person or deferrable to another date.
- C) Partial refunds shall not be issued for non-attendance.
